Overview

Zander is a Partner in our Insurance and Professional Liability practice groups, where his practice focuses on helping clients navigate large loss claims under liability and property insurance programs. Zander has assisted clients in coverage matters such as the 3M Combat Arms Multi-District Litigation (involving over 280,000 lawsuits and a \$6.01 billion mass tort settlement); the 2014 Home Depot data breach; and litigation concerning eight to ten-figure personal injury, property damage, and business interruption claims related to industrial accidents, sex abuse, COVID-19, and complex insurance arrangements including risk-purchasing groups, Owner-Controlled Insurance Programs, and excess insurance and Bermuda reinsurance.

Prior to joining Meagher + Geer, Zander served as a law clerk for the Honorable Susan Richard Nelson of the United States District Court for the District of Minnesota. Zander earned his J.D., *magna cum laude*, from the University of Minnesota Law School, and was elected to the Order of the Coif.
